On December 15, 2016, the Board of Directors of GT Capital Holdings, Inc. ("GT Capital" or the "Corporation") approved the declaration of quarterly cash dividends for its non-voting, non-participating, non-convertible, and redeemable perpetual preferred shares for the year 2017 in the amount per quarter of Pesos: Fifty Six Million Twelve Thousand Nine Hundred Ninety Three and 19/100 (Php56,012,993.19) for Series A (GTPPA) and Pesos: Ninety One Million Two Hundred Eight Thousand Three Hundred Ninety and 31/100 (Php91,208,390.31) for Series B (GTPPB), such cash dividends to be paid out of the Corporation's unrestricted retained earnings.
