#### Item 9. Other Events

On March 10, 2016, the Board of Directors of GT Capital Holdings, Inc. ("GT Capital") approved the amendment of Article II Section 1 of its Amended By-Laws moving the date of the annual/regular meeting of the stockholders from the second Monday of May to the second Wednesday of May in order to avoid coinciding with local and/or national elections every three years, which is a legal holiday pursuant to Republic Act No. 7166 (An Act Providing for Synchronized National and Local Elections and for Electoral Reforms, Authorizing Appropriations Therefor, and for Other Purposes). The revised provision shall read:

"Section 1. Annual/ Regular Meetings – The annual/regular meetings of stockholders, shall be held at the principal office on the second Wednesday of May of each year, if a legal holiday, then on the day following."

The proposed amendment is subject to the approval of the stockholders of GT Capital entitled to vote and will be included in the Agenda of the 2016 Annual Stockholders' Meeting to be held on May 11, 2016, with record date on April 1, 2016.
