Gentlemen:

In connection with the Regular Meeting of the Board of Directors (the "Board") of GT Capital Holdings, Inc. ("GT Capital" or the "Corporation") held today, June 23, 2016, we disclose that the Board authorized the following:

- (a) public offering of up to Eight Million (8,000,000) Series "A" and "B" Perpetual Preferred Shares for the Base Issue, with an Oversubscription Option of up to Four Million (4,000,000) shares (collectively, the "Shares"), at an offer price of One Thousand Pesos (Php1,000.00) per share for an up to aggregate amount of Twelve Billion Pesos (Php12,000,000,000.00). The Shares are cumulative, nonvoting, non-participating, non-convertible, and peso-denominated.
- (b) filing of the appropriate Registration Statement and Prospectus with the Securities and Exchange Commission; and
- (c) filing of listing application with the Philippine Stock Exchange of the Shares.

For these purposes, the Board has authorized the engagement of the services of underwriters, advisors, legal counsels, stock and transfer agent, receiving agent/bank, and other agents as may be necessary, proper or desirable to effect the offering. The offer of the Shares is subject to regulatory approvals.
