GT Capital Appoints Toyota Executive

(14 August 2019. Makati City, Philippines.) **GT Capital Holdings, Inc.** (GT Capital / stock symbol: GTCAP) disclosed today its appointment of Mr. Vicente Saniel Socco as Chairman of **GT Capital Auto Dealership Holdings, Inc. (GTCAD)**. GTCAD is a wholly-owned subsidiary of GT Capital and is the automotive dealership holding vehicle for the Group. He brings close to forty years of expertise in the automotive sector. Mr. Socco was appointed general affairs manager of Toyota's Manila liaison office before being assigned in 1988 to Toyota Motor Philippines Corporation (TMP), where he rose through the ranks to become senior vice president (SVP) for marketing.
