Clarification of InterAksyon.com News Article

Gentlemen:

Regarding the news article that was posted in InterAksyon.com on September 29, 2014 entitled "4 companies eye operations contract of LRT2", which reported in part that:

"MANILA - Four companies are interested in operating the Light Rail Transit Line 2.

Department of Transportation and Communications (DOTC) spokesman Michael Arthur Sagcal identified the four companies that purchased bid documents as San Miguel Corp (SMC), the joint venture of Ayala Corp (AC) and Metro Pacific Investments Corp (MPIC), GT Capital Holdings Inc, and Japan's Marubeni Corp.

DOTC set a November 20 deadline for the submission of prequalification documents, while bidding is scheduled in the second quarter of 2015.

The winning bidder will take over the operations and maintenance (O&M) of all 11 stations of LRT2, as well as the 4.19-kilometer Masinag Extension, the construction of which is scheduled to begin in January next year.

The O&M contract would last between 10-15 years.
